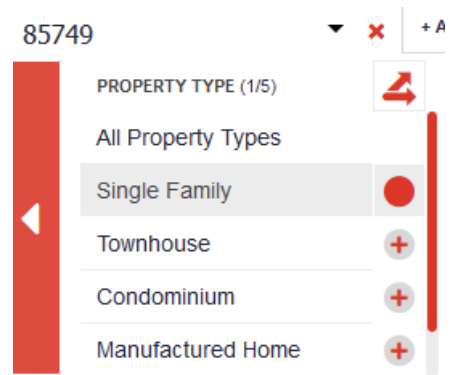

1. **Sales Price:** Calculations are based on sold data and prices do not account for seller concessions.
2. **New Listings:** A count of the properties that have been newly listed on the market in a given month.
3. **Homes for Sale:** The number of properties available for sale in active status at the end of a given month. Also known as inventory.
4. **Pending Sales:** A count of properties which a contract has been accepted in a given month
5. **Closed Sales:** A count of the actual sales that have closed in a given month.
6. **Days on Market:** Average number of days between when a property is listed and when an offer is accepted in a given month.
7. **Months Supply:** The inventory of homes for sale at the end of a given month, divided by the average monthly sales available from the last 12 months. Also known as absorption rate.
8. **Pct. of List Price:** Percentage found when dividing a listing's sales price by its listing price, then taking the average or medium for all sold listings in a given month, not counting seller concessions.
9. **Price Per Sq. Feet:** Based on sold data. Prices do not account for seller concessions.
10. **Dollar Volume:** The total dollar amount of sales for the selected criteria.

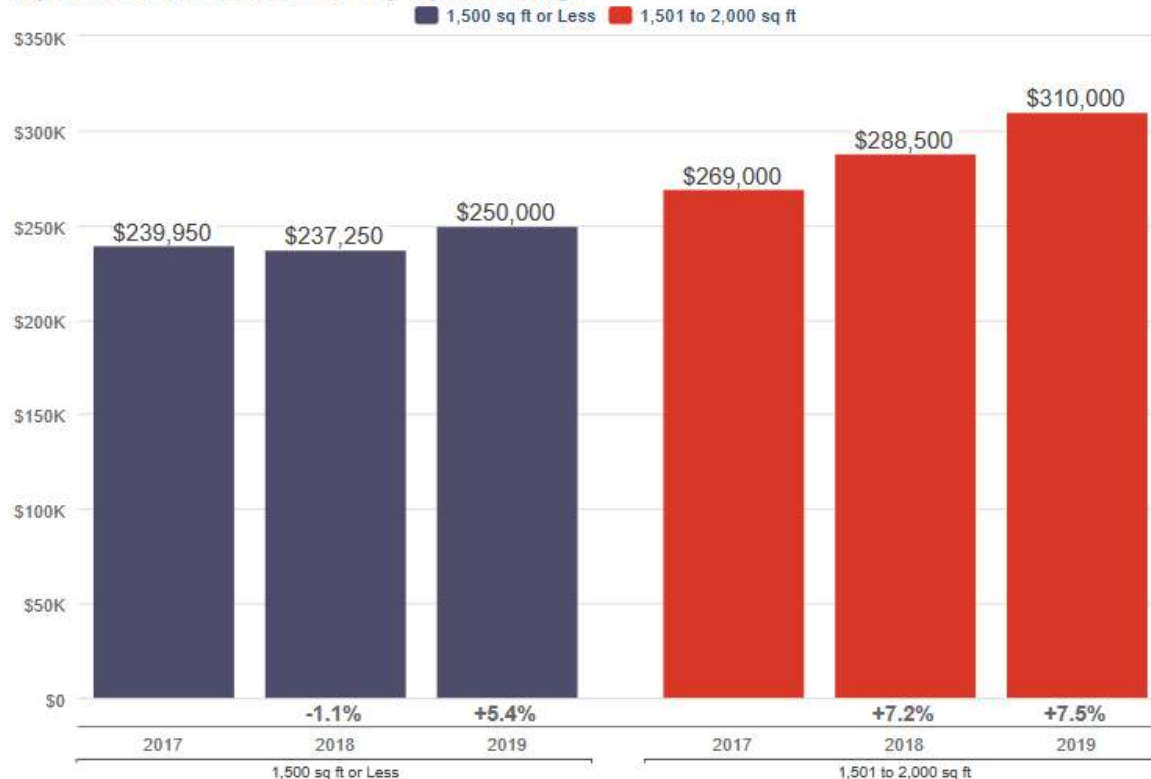

To Set-Up Your Personalized Areas:

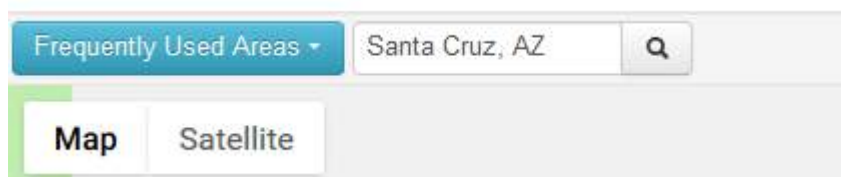

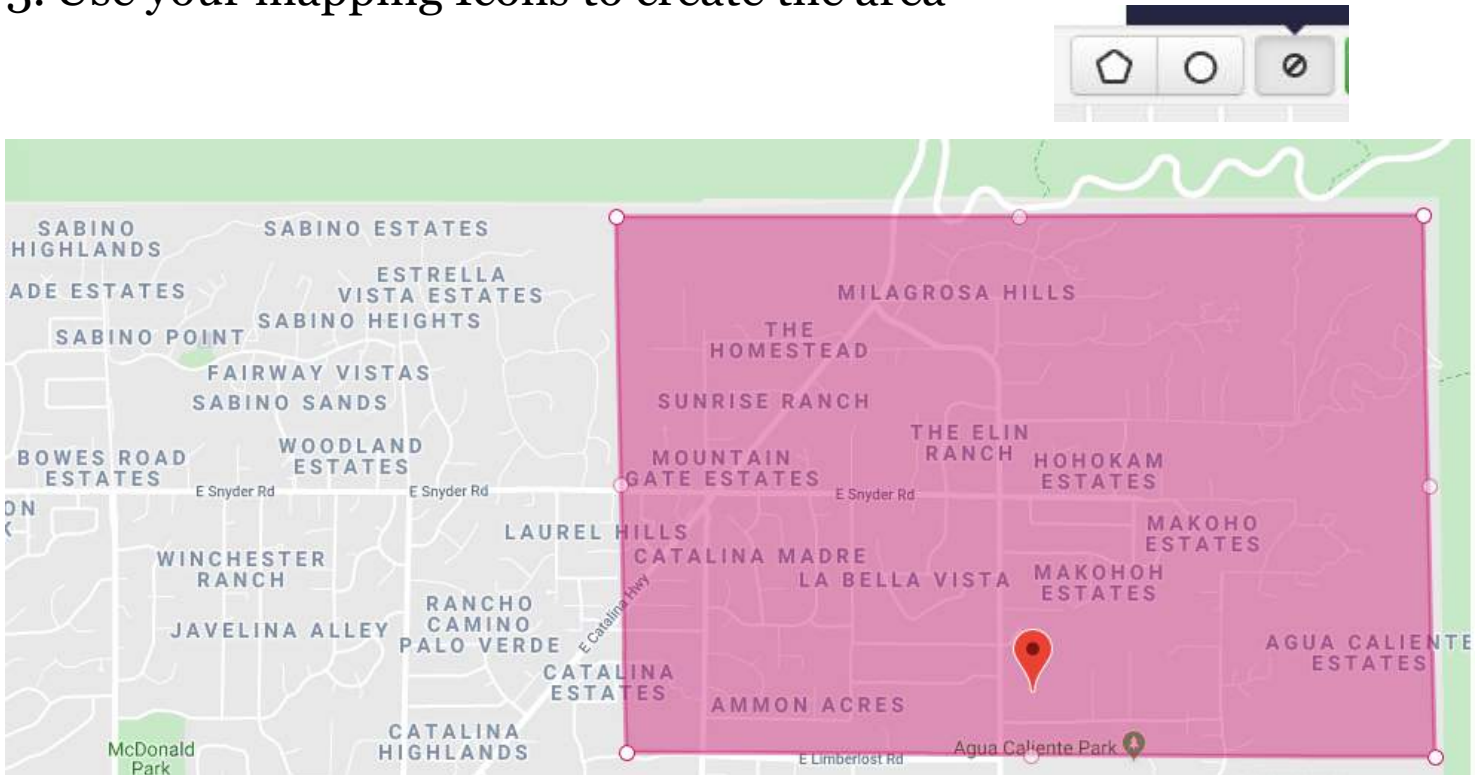
Step Three: Type in the city or zip code—When using city you want to include the two letter state abbreviation.

Creating An Area:

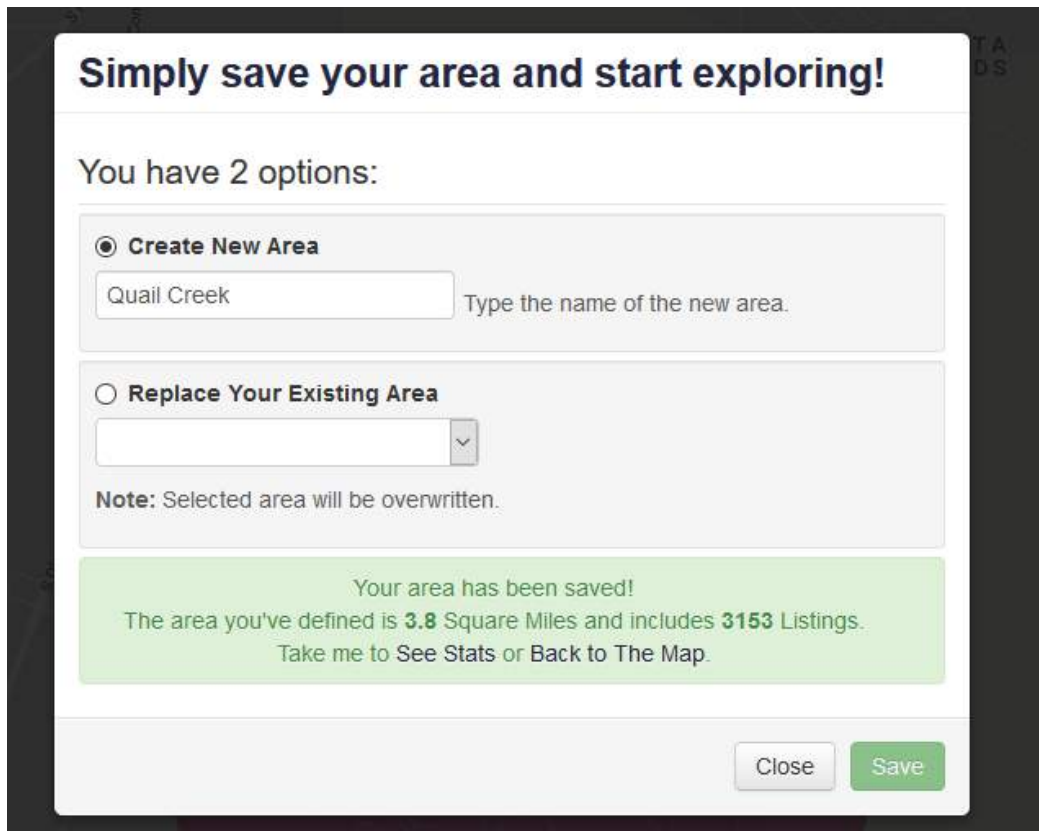
1. Click on the My Areas tab in the upper right

3. Use your mapping Icons to create the area—



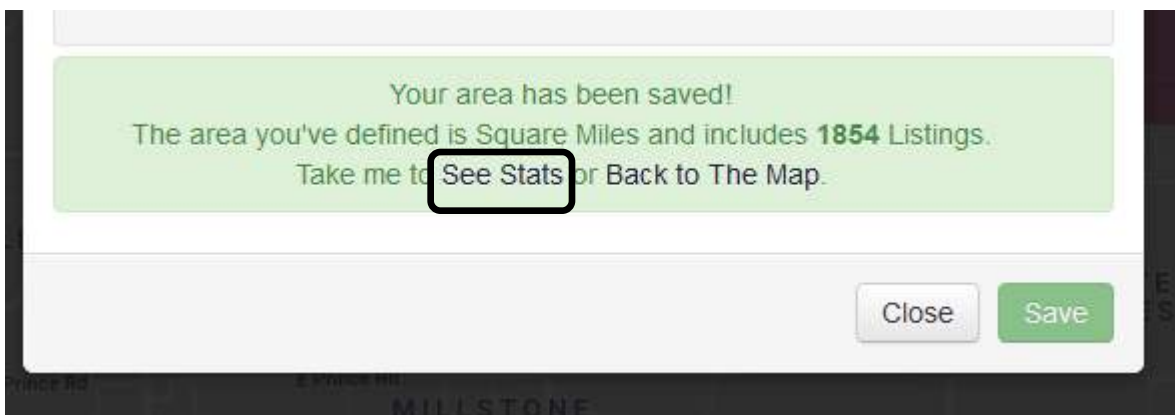
(The not sign is to erase the area and start fresh.)

When you choose save and name your search you will see this choice—choose See Stats



After returning to InfoSparks by hitting the STATS choice

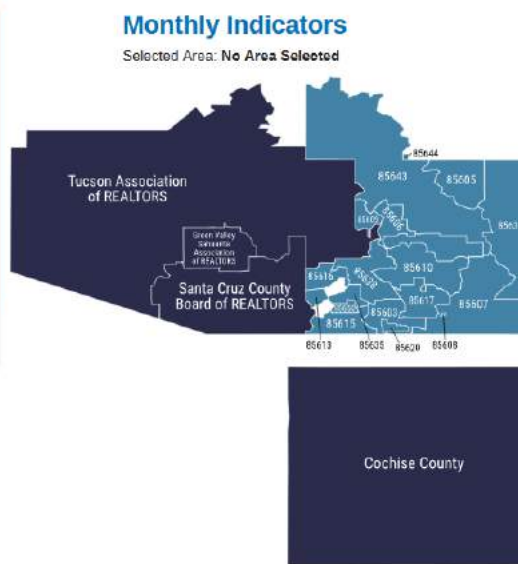

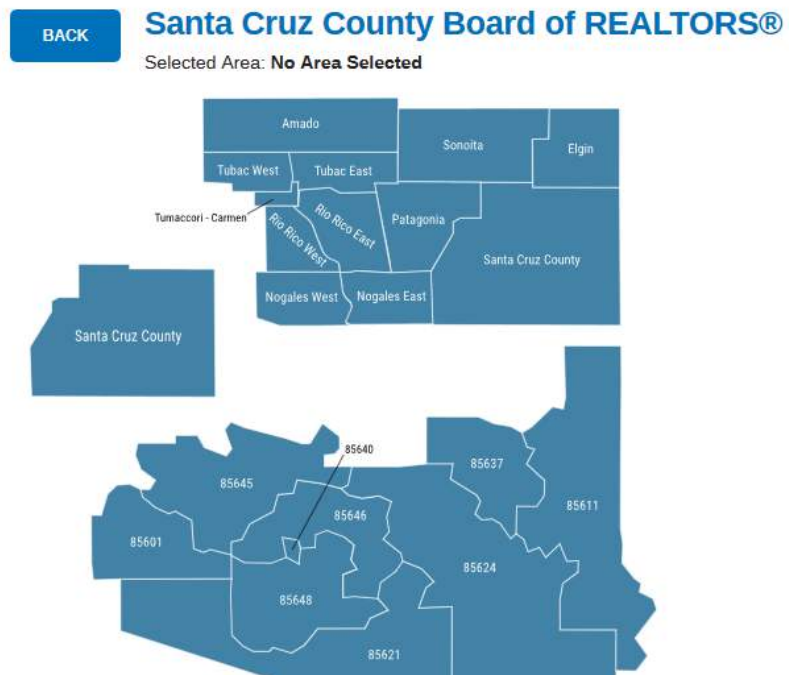

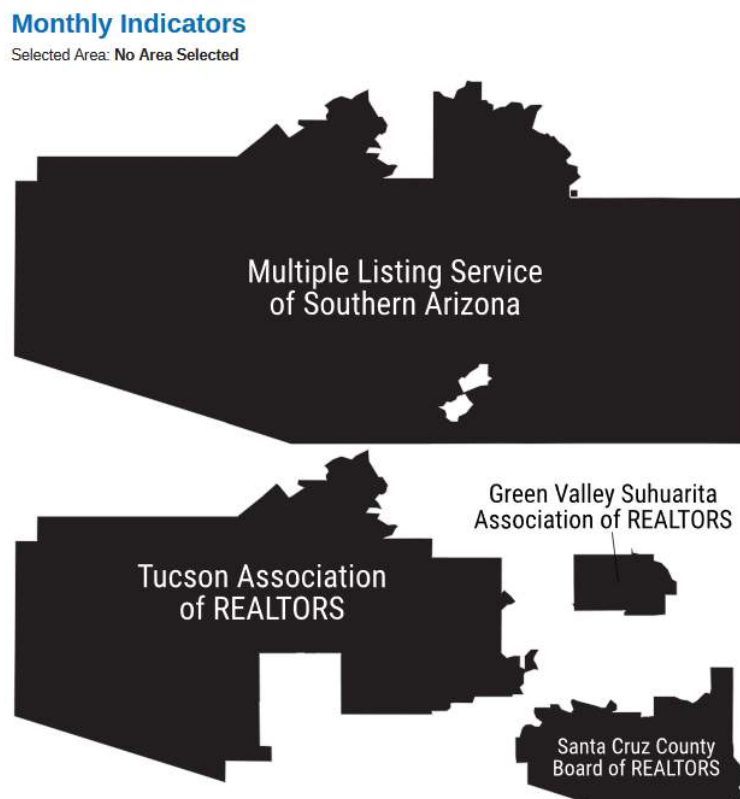

Monthly Indicators



August 2019

As the summer draws to a close, multiple opposing factors and trends are competing to define the direction of the real estate market. After the Federal Reserve lowered its benchmark interest rate on July 31, 30-year mortgage rates continued to decline, approaching all-time lows last seen in 2016. Yet most experts agree these reductions are unlikely to bring sufficient relief, at least in the short term, for first-time home buyers. The lack of affordable inventory and the persistence of historically high housing prices continue to affect the housing market, leading to lower-than-expected existing home sales at the national level.

New Listings decreased 8.0 percent for Single Family and 21.0 percent for Townhouse/Condo. Pending Sales increased 12.3 percent for Single Family but decreased 21.0 percent for Townhouse/Condo. Inventory decreased 19.4 percent for Single Family and 16.6 percent for Townhouse/Condo.

Median Sales Price increased 6.1 percent to \$239,000 for Single Family and 6.6 percent to \$169,950 for Townhouse/Condo. Days on Market decreased 7.0 percent for Single Family and 31.6 percent for Townhouse/Condo. Months Supply of Inventory decreased 21.4 percent for Single Family and 7.1 percent for Townhouse/Condo.

As many homeowners refinanced their homes to take advantage of declining interest rates, consumer confidence in housing was reported to be at historically high levels. Even so, real estate professionals will need to monitor the market for signs of continued imbalances. Although the inventory of affordable homes at this point remains largely stable, it is stable at historically low levels, which may continue to push prices higher and affect potential buyers across the U.S.

Key Principles to Remember When Looking at the Statistics

Time Calculations:

- 1) 12 months” means Rolling 12 Months. Each data point is 12 months of activity. From any given month, go back 12 months and total it up. (Always begins in January of the year before)
- 2) Another option includes Monthly: Shows only a month of activity for each data point.
- 3) Year to Date, which shows activity from January to the current month for the 1 year choice. The 1 year will be shown in chart format only.
- 4) For the categories which have a choice: Average is recommended for large sample sizes and Median is recommended for small sample sizes.
- 5) When you chose Rolling 3 months, each data point will be 3 months.
- 6) If you are unsure—choose print and view the PDF—each graph will be labeled on the bottom

***Data is updated on approximately the 6th of the month.**

*It is a national data base—be specific with city or subdivision and the state abbreviation.

FAQ:

How are co-listings and co-sales handled?

Each co-agent is given .5 units and half the dollar volume for each side.
