

# Monthly Indicators



## May 2023

Existing-home sales slid for the second consecutive month, falling 3.4% nationwide as of last measure, according to the National Association of REALTORS® (NAR), as higher interest rates continue to impact buyer affordability. Sales are down 23% compared to the same period a year ago, while contract signings dropped 20.3% year-over-year. With sales cooling, buyers in some parts of the country have found relief in the form of declining sales prices, which are down 1.7% year-over-year nationally, although more affordable markets continue to see price gains.

New Listings decreased 19.8 percent for Single Family and 18.3 percent for Townhouse/Condo. Pending Sales decreased 4.5 percent for Single Family but remained flat for Townhouse/Condo. Inventory increased 15.6 percent for Single Family and 18.3 percent for Townhouse/Condo.

Median Sales Price increased 2.4 percent to \$389,090 for Single Family and 2.2 percent to \$260,000 for Townhouse/Condo. Days on Market increased 133.3 percent for Single Family and 170.0 percent for Townhouse/Condo. Months Supply of Inventory increased 58.3 percent for Single Family and 33.3 percent for Townhouse/Condo.

While fluctuating interest rates have pushed some buyers to the sidelines, a shortage of inventory is also to blame for lower-than-average home sales this time of year, as current homeowners, many of whom locked in mortgage rates several percentage points below today's current rates, are delaying the decision to sell until market conditions improve. With only 2.9 months' supply heading into May, available homes are moving fast, with the typical home spending just over three weeks on the market, according to NAR.






## Historical Pending Sales by Month








## Historical Closed Sales by Month








## Historical Days on Market Until Sale by Month








## Historical Median Sales Price by Month







## Historical Average Sales Price by Month







## Historical Percent of List Price Received by Month




# Housing Affordability Index






## Historical Housing Affordability Index by Month



## Historical Inventory of Homes for Sale by Month






### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family


### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family


### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family


### Median Sales Price - Single-Family




### Median Sales Price - Single-Family


### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family


### Median Sales Price - Single-Family


### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family




### Median Sales Price - Single-Family
